## (4) President Report (Celina)

Discussion of new poll regarding the *mandatory* nature of pass/fail grades

-Decided there will be no new polls put to the student body via the recommendation of administration. Faculty were advised to reflect based on the pole results that were already put forth to them.

-Board decided to not consider results of the very first pole that was conduct. Reasoning: the efficacy of that pole was called into question when it was only sent out via facebook, not by email as well. Not all students utilise facebook and therefore it was not reflective of the student body. All recommendations were based solely on the results of the second pole.

-Addressed that the 1/4 of the students who do not want pass/fail have to be recognized

-Around 70% of the student body voted, 30% voted grades, 70% voted pass/fail.

-Extraordinary faculty meeting that is to be held  $\rightarrow$  Unprecedented, the formatting of said meeting is not wholly known to the board. Dean Donlan, Celina, and Arjun discussed possibility of livestreaming or recording the meeting, however the current conferencing system in the faculty boardroom may not be equipped to do such a thing.

-Inquiry made about what other accommodations are available to students  $\rightarrow$  they will be made known once the decision on grading scheme is put forth.
